Appendix A

NON-DISCLOSURE AGREEMENT (NDA) / FORM OF CONFIDENTIALITY UNDERTAKING

I, [Name] _____, from [Company Name] _____

("the Recipient") with [Company Registration Number] _____, do

solemnly undertake as follows:

1. That I shall treat and accord all Confidential Information (as defined herein) of the Government of Somalia which has been disclosed to me for the purposes of my participation and/or contribution towards the **Somalia National Transformation Plan** ("the Purpose") with the strictest of secrecy and agree to enforce each undertaking herein contained with respect to:
 - a) All information relating to the operations of the Government of Somalia, including performance information and analysis, strategies, plans, personalities, policies, intellectual property and any plans relating to the same.
 - b) All information and matters pertaining to Government of Somalia interactions (including Papers, Reports, Assessments, Decisions, Minutes of Meetings);
 - c) All classified documents belonging to the Government of Somalia;

"Confidential Information" definition:

- (a) All information:
 - i. Disclosed (whether orally, in writing or in any other form) by the Federal Government of Somalia to the Recipient; and
 - ii. Treated by the Lab as confidential.
- (b) All copies, notes and records and all related information in whatever form (including without limitation written, oral, visual, and electronic form or on tape or on disk) generated by the Recipient based on or arising out of any such disclosure; and
- (c) The terms and conditions of this Form of Undertaking.

2. That I shall use the Confidential Information only for the Purpose and in accordance with this NDA / Form of Confidentiality Undertaking.
3. That I may copy the Confidential Information only for the Purpose and must mark any such copy "Confidential".
4. That I may disclose the Confidential Information for the Purpose but only to Permitted Employees and Permitted Disclosees, to the extent that the Permitted Employee or Permitted Disclosee has a need to know.
5. A "Permitted Employee" means an officer or employee of Government of Somalia who has executed a similar NDA / Form of Confidentiality Undertaking.

A "Permitted Disclosee" means a person (other than a Permitted Employee) who:

- a) has been approved in writing by the Permanent Secretary of Federal Government of Somalia to receive any Confidential Information relating to the Purpose; and
 - b) has executed a similar NDA / Form of Confidentiality Undertaking or has agreed in writing to comply with clauses 5,6,7,8,9 and 10 of this Form of Confidentiality Undertaking.
6. That I must:
 - a) Keep the Confidential Information as it is;
 - b) Safeguard and secure all Confidential Information in accordance with legislation, policies, procedures on safety and security of Confidential Information of the Lab including but not limited to not unduly exposing or showing the Confidential Information to any unauthorized persons, whether they be staff of the Federal Government of Somalia or otherwise;
 - c) Immediately notify the Permanent Secretary, Office of the Prime Minister of Federal Government of Somalia if I:
 - (i) Suspect or become aware of any unauthorized copying, use or disclosure in any form; or
 - (ii) I am required by law, or ordered by the court decision, to disclose any Confidential Information;
 - d) Comply with any direction or instruction issued regarding a suspected or actual breach;
 - e) Not disclose to any person the fact that the Confidential Information has been made available to me or that discussions or negotiations are taking place in furtherance of the Purpose; and
 - f) Not alter, modify, tamper with, reverse engineer (if in software) or attempt to do so any part of the Confidential Information.
 7. Upon demand of the Permanent Secretary, Office of the Prime Minister of Federal Government of Somalia, I must promptly return to Federal Government of Somalia or destroy any or all copies of Confidential Information, and any right to use, copy and disclose the Confidential Information ceases.

8. That at no time shall I disclose, communicate, publish, or otherwise, whether orally or in writing or in any form, directly or indirectly to any person, except in the course of and within the scope of carrying out my duties with respect to the Purpose.
9. That I shall not retain or be in possession of, whether on or outside the premises of Federal Government of Somalia, except in the course of my duties, any such Confidential Information relating to the Purpose.
10. That this undertaking shall be effective and continue in full force and effect throughout the duration of my employment or engagement with Federal Government of Somalia (howsoever arising) and after the cessation, termination or otherwise discontinuance of such employment and/or engagement.
11. I hereby acknowledge that:
 - (a) I fully understand that in the event of any breach of this Form of Confidentiality Undertaking due to my act or omission, Federal Government of Somalia could suffer substantial loss and damage for which monetary compensation is not adequate remedy;
 - (b) Federal Government of Somalia is entitled to seek specific performance, injunctive and other equitable relief in enforcing the obligations of this Form of Confidentiality Undertaking to the maximum extent allowable under the law;
 - (c) Federal Government of Somalia reserves the right to seek recourse against me for any threatened or actual breaches of this Form of Confidentiality Undertaking to the maximum extent available under the law without having any regard for any internal the Federal Government of Somalia policies and procedures on staff matters and/or any other contractual document entered into between the Federal Government of Somalia and myself related to the Lab; and
 - (d) The Federal Government of Somalia will not disclose shared business documents that are used to validate the projects to any entities outside of the Government of Somalia.
12. This Form of Confidentiality Undertaking is governed by the laws of the Government of Somalia and both parties shall submit to the exclusive jurisdiction of the competent courts of the Federal Government of Somalia.
