Requirements:

1. Partial documents will not be accepted.
2. Tender envelopes must be sealed and stamped.
3. The Financial/Quotation and Technical documents should be submitted in separate envelopes.
4. Company profile with a verifiable contact address.
5. Most recent bank statements (showing the last 6 months of transactions and current balance).
6. Quotation Price should be in a separate envelope.
7. Valid registration certificate (Commercial license) Federal and state level.
8. Copy of passport for the company's chairperson.
9. **Branding & Visibility:** Proper branding on all cartons for clear identification.
10. **Quality & Quantity Assurance:** Ensure the correct quality and quantity of drugs & equipment.
11. **Transportation, installing & Delivery:** Supplier is responsible for delivery to the project site.
12. **Medical Supplies Package Details:** As per the attached files for Bocame, Puntland State.
13. **Delivery Locations:** All supplies to be delivered to the designated QRCS project site.
14. **Expiry Date of Drugs Supplies:** Must be more than 18 months from Jan 2025
